

LEGAL INFORMATION

The company **MASSARACH ELEVACION, SC**, with corporate offices at Carrer De la Font, 29, in Masarac (17763- Girona), with email address info@massarachelevacion.com, and Tax I.D. number J-17218298, hereby informs the user that it is the domain owner of the web page www.massarachelevacion.com

That according to the *Organic Law 15/1999 of 13 December on the Protection of Personal Data* (hereinafter LOPD, in its Spanish initials), *Law 34/2002 of 11 July 11 on the Services of the Information Society and Electronic Commerce* (hereinafter LSSICE, in its Spanish initials), and the *European Regulation 2016/679 of 27 April, 2016, regarding the protection of natural persons regarding their personal data and the free movement thereof* (hereinafter European Regulation 2016/679), **MASSARACH ELEVACION, SC**, hereby informs the user of the following:

1. TERMS OF USE:
